DIRECTIONS TO TRIAL SITE:

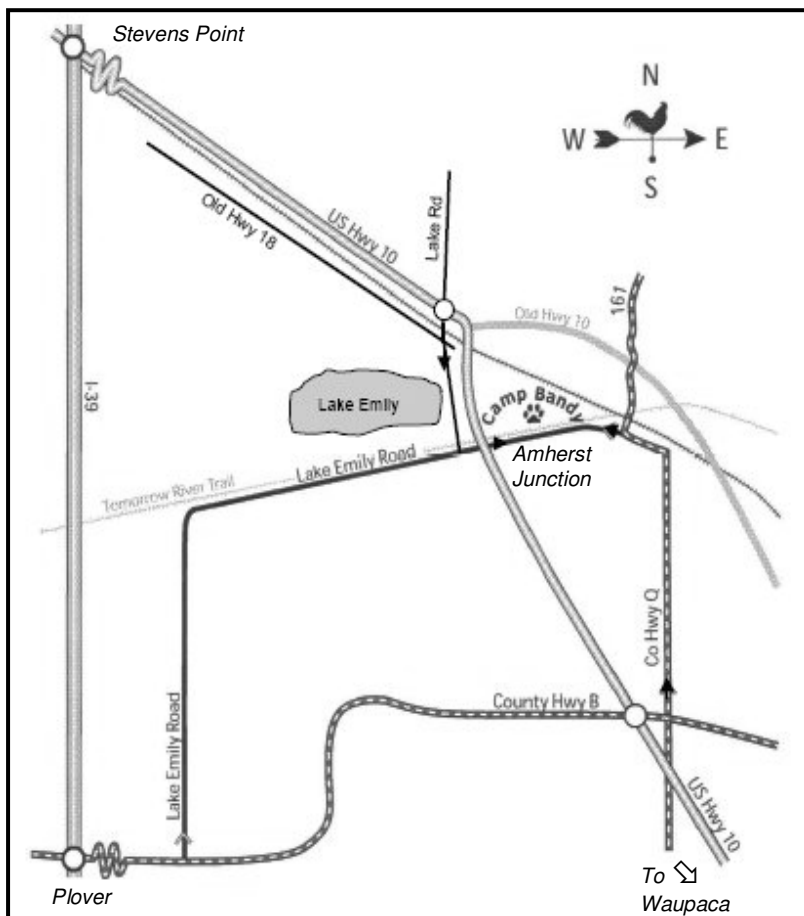
FROM NORTH, SOUTH AND WEST:

Take I-39 to Hwy 10 East (toward Waupaca). Take Lake Road/Amherst Junction Exit and turn right. Cross Old Hwy 18 Rd and continue on Lake Road (Lake Emily will be on your right). Turn left on Lake Emily Rd. Camp Bandy is on the Left (approximately 5 blocks).

NOTE: Large motor homes may wish to continue on Hwy 10 to Hwy B Exit, turn left onto Cty Rd B and follow directions below from there.

FROM EAST:

Take Hwy.10 West just past Amherst to County Road B WEST Exit. Turn right onto Cty Rd B. Almost immediately, turn left onto County Road Q. Approx 1 mile down, road makes a sharp turn to the left and becomes Main Street. Stay on Main St as it angles left and becomes Lake Emily Rd. Camp Bandy is on the Right just out of town (approximately 3 blocks).
